REGISTRATION OF TITLE ACT, No. 21 of 1998

REGULATIONS made by the Minister of Tourism and Lands by virtue of the powers vested in him under Section 67 of the Registration of Title Act, No. 21 of 1998.

HARIN FERNANDO, Minister of Tourism and Lands.

Regulations

Amendments published in the *Gazette* No.1886/58 of 31st October 2014, made to the Registration of Title Regulations, No. 21 of 1998 published in *Gazette Extraordinary*, No. 1050/10 of 21st October 1998, are further hereby amended as follows:

1. By the repeal of Regulation 1(a) of the *Gazette* No.1886/58 of 31.10.2014 and the substitution therefor of the following paragraph :-

 - (a) Property section:- Which shall adequate to include a brief description of the property, its encumbrances appurtenances, parcels and the cadastral map number, block number and sheet number of each parcel.
 - 2. By the repeal of Regulation 07(1) of the *Gazette* No.1050/10 and dated 21.10.1998 and the substitution therefor of the following paragraph:-

"Publishing of the determination of the Commissioner General of Land Title Settlement"

"07) (1) A schedule containing the determination of the Commissioner made under Section 14 of the Principal Enactment in respect of such land parcel or land parcels, shall be published in the Government *Gazette* substantially in the Form 4 of the First Schedule hereto.

3. By imposing the following regulation as Regulation 28 to refer the claims to the District Court, in Section 21 of the Principal Enactment;

"In case of the opinion of the Commissioner General of Title Settlement that it is more suitable to carry out the investigation activities by the District Court due to nature of the disputes of claiming, the same dispute shall be forwarded to the District Court which is within whose area of jurisdiction the land dealt with by a transfer complaint and affidavit. The complaint and the affidavit forwarded to the Court by the Commissioner General for the same Regulation shall be substantially to the Form No.37 and 38 of the First Schedule to these regulations respectively".

- 4. Regulation 15(1) (e) is included in to the *Gazette* No.1886/58 and dated 31.10.2014 and it shall be as follows:-The file number or code number provided by the Registrar General with the signature and the Official stamp of the Notary Public shall be included in the forms mentioned 15 (1) (a) above.
- 5 Regulation 15(1) (f) is included in to the *Gazette* No.1886/58 and dated 31 .10.2014 and it shall be as follows:-"Action should be taken to cancel if any prior registration sales agreements before applying for register in the Title Register by him /them for the same land /lands, on an application for amalgamation or Sub-division of a land which has been attested by a Notary Public/Acquisition Officer to a land parcel/land parcels which has been registered in the Title Register."
- 6. In addition to the regulation 13 (I) and (II) for Section 36 thereof ,the *Gazette* No.1050/10 and dated 21.10.1998, the following regulation shall be included as (III) .
 " (III) Power is vested to the Surveyor to include the name/names of the holder/holders of new land parcels or original owner/owners in to the land tenement list ,for a land parcel or percentage which is allotted by a survey on the written sanction /agreement obtained from the owner/owners to the form 39 in the first schedule in the regulations hereto in an instance of transferring of a land with title certificate/certificates or Sub-divisions, amalgamation, sale, transferring".
- 7. By the repeal of Regulation 04 of the *Gazette* No.1886/58 and dated 31.10.2014 and the substitution therefor of the following paragraph:"15(I)(a) The Format of the instruments (Section 43(I)) –which concerns any allotment of land where registered in the Register of Title and is certified by a Notary Public shall be in accordance with such Forms prepared in durable A4 size papers as set out below:-
- (i) "Transfer or a Sale", shall be substantially in Form No. 8 of the First Schedule to these regulations;
- (ii) "Sales Agreement", shall be substantially in Form No. 23 of the First Schedule to these regulations;
- (iii) "Transfer made for Security Bonds", shall be substantially in Form No. 24 of the First Schedule to these regulations;
- (iv) "Registration of Certificate of Sale", shall be substantially in Form No. 25 of the First Schedule to these regulations;
- (v) "Cancellation of Sales Agreement", shall be substantially in Form No. 26 of the First Schedule to these regulations;

- (vi) "Gift," shall be substantially in Form No. 9 of the First Schedule to these regulations;

- (ix) "Lease", shall be substantially in Form No. 10 of the First Schedule to these regulations;
- (x) "Cancellation of Lease", shall be substantially in Form No. 29 of the First Schedule to these regulations;
- (xi) "Mortgage", shall be substantially in Form No. 11 of the First Schedule to these regulations;
- (xii) "Cancellation of Mortgage", shall be substantially in Form No. 12 of the First Schedule to these regulations;
- (xiii) "Caveat", shall be substantially in Form No. 13 of the First Schedule to these regulations;
- (xiv) "Cancellation of Caveat", shall be substantially in Form No. 30 of the First Schedule to these regulations;
- (xv) "Registration of an Address", shall be substantially in Form No. 31 of the First Schedule to these regulations;
- (xvi) "Request for Amalgamation/Subdivision of a land", shall be substantially in Form No. 7 of the First Schedule to these regulations;
- (xvii) "Register a Condominium Property", shall be substantially in Form No. 21 of the First Schedule to these regulations ;
- (xviii) "Exchange of Land", shall be substantially in Form No. 32 of the First Schedule to these regulations;
- (xix) "Cancellation of life interest when the life interest holder deceased" shall be substantially in Form No. 33 of the First Schedule to these regulations;
- (xx) "Cancellation of sales certificate" shall be substantially in Form No. 34 of the First Schedule to these regulations;
- (xxi) "Transfer of right of way/right to access with servitude "shall be substantially in Form No. 35 of the First Schedule to these regulations;
- (xxii)"Leasing out by the life interest holder" shall be substantially in Form No. 36 of the First Schedule to these regulations;
- (b) The Registrar General of Title may determine and accept where possible, for the purpose of the expeditious registering of lands in the Register of Title, Formats prescribed under any other Enactment for the registration of transactions relating to land.
- (c) Notwithstanding anything contained in sub paragraph (b) of paragraph (2) of this regulation, where the instrument for registration is a Cancellation of a Gift, the submission of the original Certificate of Title in respect of such Gift shall not be mandatory. The Registrar of Title shall in registering of such instrument, register the Cancellation of Gift and forthwith inform the Donee of such cancellation. Once the cancellation is so registered, the Registrar of Title shall not register in the Title Register any instrument submitted to him by the Donee of any transaction in respect of such Gift.
- (d) (1) A Notary Public who attests an instrument in terms of Section 23 of the Notaries Ordinance (Chapter 107) shall forward the attested instrument to the Registrar of Title within whose area of jurisdiction the land dealt with in such instrument is situated and a copy of such instrument shall be retained with the Notary Public who attests such instrument."

(3) A Notary Public who attests an instrument in terms of Sub-section 16(10)(b)(iii) of the Notaries Ordinance (amended) No.31 of 2022 shall forward the attested instrument to the Registrar of Title within whose area of jurisdiction the land dealt with in such instrument is situated, in duplicates of such instrument and in one copy of thereof shall be placed his official stamp by fixing certified photographs in passport size of the parties and the copy of the National Identity Card, Passport or the Driving License and the original copy of the receipt which is stamp fees paid shall be affixed to the other copy.

- 8. By the repeal of Regulation (c) and (d) of the Paragraph 7.21(I) of the *Gazette* No.1886/58 and dated 31.10.2014 and the substitution therefor of the following paragraph;-
 - "(c) Title Certificate issued in registration of Temporary Condominium Property shall be substantially in Form No. 14 (b) of the First Schedule to these regulations;
 - (d) Title Certificate issued in registration of Partly- Condominium Property, shall be substantially in Form No. 14 (c) of the First Schedule to these regulations;"
- 9. Regulation (e) of the paragraph 7.21(I) is included into the *Gazette* No.1886/58 and dated 31.10.2014 and it shall be set out as below.

"(e) Title Certificate issued in Registration of Full Condominium Property, shall be substantially in Form No. 14 (d) of the First Schedule to these regulations.
